



## PRODUCT USE RIGHTS DOCUMENT FOR INFOSCALE OPERATIONS MANAGER

This Product Use Rights Document ("Document") contains additional terms and conditions (the "Product Use Rights") for the Licensed Software licensed under the Veritas Software License Agreement ("License Agreement") between You as the individual, the company, or the legal entity that will be utilizing the Licensed Software (referenced below as "You" or "Your") and Veritas Technologies LLC. Capitalized terms used in this Document but not defined herein will have the meaning given in the License Agreement. To the extent there is a conflict between the terms and conditions of the License Agreement and this Document, the terms and conditions of this Document will take precedence.

BY DOWNLOADING, INSTALLING OR USING THE LICENSED SOFTWARE, YOU AGREE TO COMPLY WITH THE PRODUCT USE RIGHTS IN THIS DOCUMENT, IN ADDITION TO THE TERMS AND CONDITIONS OF THE LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THE PRODUCT USE RIGHTS APPLICABLE TO THE LICENSED SOFTWARE, DO NOT DOWNLOAD, INSTALL OR USE THE LICENSED SOFTWARE.

For purposes of this Document, the Licensed Software is: InfoScale Operations Manager

### 1. **ADDITIONAL DEFINITIONS:**

**"Server"** means an individual computer, acting as a service or resource provider to client computers by sharing the resources within the network infrastructure. A Server can run server software for other computers or devices.

**"Managed Server"** means a Server that is managed, monitored and/or protected by the Licensed Software but that may not actually be running the Licensed Software itself.

2. **USAGE RIGHTS.** You may use the Licensed Software on an unlimited number of Managed Servers in support of authorized licenses of the Veritas Products set forth below which are under current maintenance/support.

In the event You have a current license to (i) Storage Foundation High Availability version 5.1 SP1 or later on Linux or (ii) Storage Foundation High Availability version 5.1 SP2 or later on Windows, in addition to the rights granted to You in the license agreement for such Storage Foundation High Availability product ("SFHA"), You may also install such SFHA product on the same Servers as those on which the Licensed Software management servers are running solely to set up (i) a two-node Veritas Cluster Server cluster in which the Licensed Software management server is installed and (ii) a remote node for disaster recovery and protect the Licensed Software from local failures and disasters. No other use, except as indicated in the licensed agreement for such SFHA product, may be made.

### 3. **STORAGE INSIGHT SOFTWARE DEVELOPMENT KIT (the "SDK").**

3.1. **DEVELOPMENT LICENSE.** Your license of the Licensed Software may include a license for the Storage Insight Software Development Kit ("SDK"). Subject to Your compliance with the terms and conditions of this Section, Veritas grants to You a non-exclusive, non-transferable license to use the SDK on an unlimited number of Managed Servers solely to (i) enhance the array support for VOM to enable new arrays not supported natively by such products to be discovered by VOM and (ii) to develop add ons (each being an "Add On") through the exercise of the rights granted under clause (i) of this Section. Your license of the SDK may only be used in support of VOM and only in support of the software products as described in Section 2. You shall have no right to modify or alter the SDK or to develop Add Ons for any other product.



3.2. **NO REDISTRIBUTABLE CODE.** The SDK itself shall only be distributed by You within your own internal organization and shall be used by You for your internal use and may be not be distributed by You, in whole or in part, in any manner whatsoever to any third party. For Veritas-authorized distributors or resellers of VOM or Veritas-authorized consulting services providers, You have the right to distribute any resulting Add Ons to licensees of VOM solely for the purposes of supporting the software products as described in Section 2. Otherwise, any resulting Add Ons shall only be distributed by You within your own internal organization and shall be used by You for your internal use and may be not be distributed by You, in whole or in part, in any manner whatsoever to any third party.

3.3. **OPEN SOURCE CODE.** Your license rights to the SDK are conditioned upon your not creating derivative works of the SDK in any manner that would cause the SDK in whole or in part to become Open Source Code. "Open Source Code" means a software program that is licensed under terms that require disclosure to parties other than the licensor of the source materials of the software program or modifications thereof, or any source materials of any other software program with which the Open Source Code software program is intended to operate, or that create obligations to distribute any portions of any software program with which the Open Source Code software program is used. Open Source Code includes, without limitation, any software licensed under the GNU General Public License.

3.4. **OWNERSHIP/TITLE.** As further described in Section 4 of this License Agreement, the SDK and any Add Ons are the proprietary property of Veritas or its licensors and is protected by copyright law. Veritas and its licensors retain any and all rights, title and interest in and to the Licensed Software, including in all copies, improvements, enhancements, modifications and derivative works of the Licensed Software and any Add Ons thereto. Your rights to use the SDK and Add Ons shall be limited to those expressly granted in this License Agreement. All rights not expressly granted to You are retained by Veritas and/or its licensors.

3.5. **NO WARRANTY. THE SDK IS PROVIDED "AS IS," EXCLUSIVE OF ANY WARRANTY, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT, OR ANY OTHER WARRANTY, WHETHER EXPRESSED OR IMPLIED. THE SDK IS PROVIDED GRATUITOUSLY AND, ACCORDINGLY, VERITAS SHALL NOT BE LIABLE UNDER ANY THEORY FOR ANY DAMAGES SUFFERED BY YOU OR ANY USER OF THE LICENSED SOFTWARE.
