



## SYMANTEC TECHNOLOGY LICENSE AGREEMENT

SYMANTEC CORPORATION AND/OR ITS AFFILIATES ("SYMANTEC") IS WILLING TO LICENSE THE LICENSED SOFTWARE TO YOU AS THE INDIVIDUAL, THE COMPANY, OR THE LEGAL ENTITY THAT WILL BE UTILIZING THE LICENSED SOFTWARE (REFERENCED BELOW AS "YOU" OR "YOUR") ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS OF THIS LICENSE AGREEMENT ("LICENSE AGREEMENT"). READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE USING THE LICENSED SOFTWARE. THIS IS A LEGAL AND ENFORCEABLE CONTRACT BETWEEN YOU AND SYMANTEC. BY CLICKING THE "I AGREE" OR "YES" BUTTON, OR OTHERWISE INDICATING ASSENT ELECTRONICALLY, OR LOADING OR OTHERWISE USING THE LICENSED SOFTWARE, YOU AGREE TO THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, CLICK THE "I DO NOT AGREE" OR "NO" BUTTON OR OTHERWISE INDICATE REFUSAL AND MAKE NO FURTHER USE OF THE LICENSED SOFTWARE.

1. **License Rights.** Subject to Your compliance with the terms and conditions of this License Agreement, Symantec grants to You a non-exclusive, non-transferable license to use a reasonable number of copies of the Licensed Software solely (i) in support of Your use of other Symantec software for which You have a license, (ii) Your development of applications which operate in conjunction with Symantec software, or (iii) Your performance of assessments of customer environments for implementation of a Symantec product on the customer environment as part of Your activities under a separate sales or distribution agreement with Symantec; You may only perform such assessments with the Licensed Software if you have prior written authorization from the customer to do so. "Licensed Software" means the Symantec software program You wish to download and use and the associated program documentation, if any.
2. **License Restrictions.** You may not, without Symantec's prior written consent, conduct, cause or permit the: (i) use, copying, modification, rental, lease, sublease, sublicense, or transfer of the Licensed Software except as expressly provided in this License Agreement; (ii) creation of any derivative works based on the Licensed Software, except as expressly provided in this License Agreement; (iii) reverse engineering, disassembly, or decompiling of the Licensed Software (except that You may decompile the Licensed Software for the purposes of interoperability only to the extent permitted by and subject to strict compliance under applicable law); (iv) use of the Licensed Software in connection with service bureau, facility management, timeshare, service provider or like activity whereby You operate or use the Licensed Software for the benefit of a third party; or (v) use of the Licensed Software by any party other than You, except as expressly provided in this License Agreement.
3. **Ownership/Title.** The Licensed Software is the proprietary property of Symantec or its licensors and is protected by copyright and patent laws. Symantec and its licensors retain any and all rights, title and interest in and to the Licensed Software, including in all copies, improvements, enhancements, modifications and derivative works of the Licensed Software. Your rights to use the Licensed Software shall be limited to those expressly granted in this License Agreement. All rights not expressly granted to You are retained by Symantec and/or its licensors.
4. **Third Party Programs.** This Licensed Software may contain third party software programs ("Third Party Programs") that are available under open source or free software licenses. This License Agreement does not alter any rights or obligations You may have under those open source or free software licenses. Notwithstanding anything to the contrary contained in such licenses, the disclaimer of warranties and the limitation of liability provisions in this License Agreement shall apply to such Third Party Programs.
5. **No Support or Maintenance.** Symantec is under no obligation to provide support or maintenance for the Licensed Software; however, Symantec may at its sole discretion elect to provide certain support for the Licensed Software. Symantec's election to provide support in one instance does not obligate Symantec to continue to supply support. Symantec is under no obligation to develop, modify, improve, or maintain the Licensed Software.
6. **Term and Termination.** This License Agreement will continue as long as You are in compliance with its terms. In the event You breach this License Agreement, it will automatically terminate. Notwithstanding anything to the contrary in the foregoing, Symantec in its sole discretion may terminate this License Agreement by providing You with five (5) days prior written notice. Upon termination, You must immediately stop using and destroy all copies of the Licensed Software within Your possession or control. The Ownership/Title, Warranty and Limitation of Liability and General sections of this License Agreement will survive termination of the Agreement.
7. **Warranty and Limitation of Liability.**



- 7.1. Warranty Disclaimer.** THE LICENSED SOFTWARE IS PROVIDED "AS IS," EXCLUSIVE OF ANY WARRANTY, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT, OR ANY OTHER WARRANTY, WHETHER EXPRESSED OR IMPLIED.
- 7.2. Limitation of Liability.** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL SYMANTEC BE LIABLE TO YOU FOR ANY DIRECT, SPECIAL, CONSEQUENTIAL, INDIRECT OR SIMILAR DAMAGES, INCLUDING ANY LOST PROFITS OR LOST DATA, ARISING OUT OF THE USE OR INABILITY TO USE THE LICENSED SOFTWARE, EVEN IF SYMANTEC HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- SOME STATES AND COUNTRIES, INCLUDING MEMBER COUNTRIES OF THE EUROPEAN ECONOMIC AREA, DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.
- 8. Export Regulation.** You acknowledge that the Licensed Software and related technical data and services (collectively "Controlled Technology") are subject to the import and export laws of the United States, specifically the U.S. Export Administration Regulations (EAR), and the laws of any country where Controlled Technology is imported or re-exported. You agree to comply with all relevant laws and will not to export any Controlled Technology in contravention to U.S. law nor to any prohibited country, entity, or person for which an export license or other governmental approval is required.
- 9. Privacy and Data Collection.**
- 9.1. Transmitted Information.** The Licensed Software collects from Your environment and automatically transmits certain data to Symantec, which may include, without limitation, operating system name, operating system architecture, processor make, processor speed, disk manufacturer, tape manufacturer, NIC card manufacturer, network speed, total times a tool has been run, number of tool runs failed, number of tool runs done remotely, and backup strategies widely used ("Transmitted Information"), unless You opt out of the data collection by disabling any optional feature included with the Licensed software. The foregoing information will not be correlated with any personal information and will be used for the purposes of: (i) enabling and optimizing the performance of the Licensed Software, (ii) internal research and development, including improving Symantec's products and services, and/or (iii) statistical analysis of product deployment, including analysis of trends and comparison in the aggregated install base. You will be able to use the Licensed Software even if You opt out of the collection and transmission of the Transmitted Information.
- 10. General.** You may not assign the rights granted hereunder or this License Agreement, in whole or in part and whether by operation of contract, law or otherwise, without Symantec's prior express written consent. Symantec may audit Your use of the Licensed Software. If You are located in North America or Latin America, this License Agreement will be governed by the laws of the State of California, United States of America. If You are located in China, this License Agreement will be governed by the laws of the Peoples Republic of China. Otherwise, this License Agreement will be governed by the laws of England. Such governing laws are exclusive of any provisions of the United Nations Convention on Contracts for Sale of Goods, including any amendments thereto, and without regard to principles of conflicts of law. If any provision of this License Agreement is found partly or wholly illegal or unenforceable, such provision shall be enforced to the maximum extent permissible, and remaining provisions of this License Agreement shall remain in full force and effect. A waiver of any breach or default under this License Agreement shall not constitute a waiver of any other subsequent breach or default. This License Agreement is the complete and exclusive agreement between You and Symantec relating to the Licensed Software and supersedes any previous or contemporaneous oral or written communications, proposals, and representations with respect to its subject matter.
