

This document (the "Certificate") is a legal agreement between the end user (the "Licensee") and Veritas Technologies LLC and/or its subsidiaries ("Veritas"). This Certificate and the rights granted herein are only effective as to end users who have a valid license pursuant to a Veritas license agreement (the "License Agreement") and a valid support agreement ("Support Agreement") for Basic Maintenance or Essential Support ("Underlying Support") for the underlying Veritas software products ("Software") for which Extended Technical Support (as defined below) will be provided. Terms not defined herein shall have the meaning given to them in Veritas' Enterprise Technical Support Policy, the Support Agreement, Global End of Life Policy or the License Agreement. This Certificate applies to the products and/or services identified on the front of this Certificate (or if not on the face of this Certificate then in the entitlement details page of Licensee's account within the Veritas Licensing Management portal).

IF LICENSEE DOES NOT AGREE TO THESE TERMS, THEN VERITAS IS UNABLE TO PROVIDE THE SUPPORT DESCRIBED HEREIN TO LICENSEE. RECEIPT OF SUCH SUPPORT INDICATES LICENSEE'S AGREEMENT TO THESE TERMS.

Extended Technical Support Offering: Commencing on the issue date, Veritas will provide to Licensee the extended support service(s) ("ETS") for Software in its Extended Support lifecycle phase and within the product family Licensee has purchased, within the Veritas region in which the Software is licensed for use as indicated in the License Agreement. Eligible Software for ETS is detailed at <https://sort.veritas.com/eosl>. ETS is provided under the terms and conditions listed below, until the end date.

- Access to technical support on a 24x7 basis (for Licensee's who have purchased Essential Support as the Underlying Support) or Regional Business Hours (for Licensee's who have purchased Basic Maintenance as the Underlying Support);
- Access to the Veritas technical support website; and
- Provision solely of known fixes, patches, workarounds, existing maintenance packs, or information from Veritas' technical knowledge base.

Terms and Conditions:

- **Payment:** Licensee's right to receive ETS is subject to payment of fees for both the required Underlying Support and such ETS. If Licensee fails to pay such fees, and the amount due remains unpaid ten (10) days following written notice to Licensee of non-payment, then Veritas shall have the right to suspend or terminate the provision of ETS. The requirements in this Certificate to maintain and pay for Underlying Support are separate from and do not change Licensee's obligation to maintain and pay for Underlying Support under any other agreement between Veritas and Licensee.
- **Applicability of Support Policies:** Except as otherwise provided in this Certificate, ETS will be provided in accordance with Veritas' Enterprise Technical Support Policy, Global End of Life Policy and other support policies that may be revised and updated by Veritas from time to time without notice to Licensee. - **Designated Contacts:** Only those Designated Contacts under the Support Agreement may contact Veritas technical support for ETS under this Certificate. No additional Designated Contacts are included in ETS.
- **Privacy and Data Protection.** For the purpose of providing Support to End User pursuant to this Certificate, Veritas will require End User to supply certain personal information (such as business contact names, business telephone numbers, business e-mail addresses). End User acknowledges that Veritas is a global organization, and such personal information may be accessible on a global basis by Veritas affiliates, by Veritas partners and subcontractors, including in countries that may have less protective data protection laws than the country in which End User is located. By providing such personal information, End User consents to Veritas using, transferring and processing this information on a global basis for the use described above. - **ETS Warranty.** Veritas warrants, for a period of thirty (30) days from the date of performance of ETS purchased under this Certificate, that such ETS will be performed in a manner consistent with generally accepted industry standards.

For ETS not performed as warranted in this provision, and provided Licensee has reported such non-conformance to Veritas within thirty (30) days of performance of such non-conforming ETS, Veritas will, at its discretion, either correct any nonconforming ETS or refund the relevant fees paid for the nonconforming ETS. THIS IS LICENSEE'S EXCLUSIVE REMEDY AND VERITAS' SOLE LIABILITY ARISING IN CONNECTION WITH THE ETS WARRANTY DESCRIBED IN THIS SECTION.

DISCLAIMER OF DAMAGES: TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL VERITAS BE LIABLE TO LICENSEE FOR (i) ANY COSTS OF PROCUREMENT OF SUBSTITUTE OR REPLACEMENT GOODS AND SERVICES, LOSS OF PROFITS, LOSS OF USE, LOSS OF OR CORRUPTION TO DATA, BUSINESS INTERRUPTION, LOSS OF PRODUCTION, LOSS OF REVENUES, LOSS OF CONTRACTS, LOSS OF GOODWILL, OR ANTICIPATED SAVINGS OR WASTED MANAGEMENT AND STAFF TIME; OR (ii) ANY SPECIAL, CONSEQUENTIAL, INCIDENTAL OR INDIRECT DAMAGES WHETHER ARISING DIRECTLY OR INDIRECTLY OUT OF THE PROVISION OF ETS EVEN IF THE PARTY, ITS RESELLERS, SUPPLIERS OR ITS AGENTS HAS BEEN TOLD SUCH DAMAGES MIGHT OCCUR.
