

#### How it Works

Our transcription process leverages cutting-edge technology to ensure accuracy and efficiency in converting audio and video files into text. Veritas Transcription Services offers a seamless solution for monitoring electronic communications by employing advanced transcription models and purpose-built review tools.

The process starts with capturing the audio with a call recording tool like Verint, Dubber, Nice, etc. Veritas then captures the audio and video files directly via API or customer exports. These files are transcribed, indexed, and classified. The transcriptions and the attached audio/video are seamlessly added to the message bodies and archived for Supervision and eDiscovery.



#### **Processing Technology**

Veritas utilizes Microsoft's Azure Al Speech technology, consisting of two transcription models:

- Microsoft Azure Speech Whisper: This model transcribes audio files into text. Trained on a vast dataset of English audio and text,
  it ensures high accuracy in transcribing speech. The model is optimized for English but can be transcribed into other languages.
- Microsoft Al Speech Batch Transcription: Batch transcription processes large volumes of audio data stored within and outside Azure. It caters to applications requiring bulk transcription, including transcriptions for pre-recorded audio, contact center post-call analytics, and diarization.

These models offer speech-to-text and text-to-speech capabilities, enabling accurate transcription, natural-sounding speech synthesis, translation of spoken audio, and speaker recognition during conversations.

Leveraging Microsoft Azure Al Speech technology with two transcription models ensures accuracy and efficiency.

#### **Purpose-Built Review**

After transcription, audio and video files undergo postprocessing review in Veritas Surveillance. This step facilitates hot word review and supports eDiscovery investigations, ensuring comprehensive analysis and compliance adherence.

- Option to bring in transcript only or include original video.
- Classification and Hot word hits appear within the transcript.
- Transcript appears in line with the message body for easy review.




Figure 2: Initiative View for Voice/Video

This combination of advanced transcription technology and purpose-built review tools




Figure 3: Immersive AI transcript player.
