BETTER EDISCOVERY MEANS FASTER DELIVERY TO CLIENTS

Processing data to make evidence easier to find is a key component of the services that GRC Solutions provides to customers. For some customers, the firm is handling 20 to 30 TB of data at a time. GRC Solutions realized it needed a better technology solution for managing, indexing, and sifting through large volumes of documents in various formats. “We needed to help customers respond more quickly and more easily to legal and compliance discovery requests,” Bordon says.

Souza had used the Veritas™ eDiscovery Platform in a previous job. GRC Solutions was working with consulting firm InventCloud. When his contact at InventCloud introduced Souza to a Veritas representative, Veritas became the front-runner among the four eDiscovery vendors GRC Solutions was considering.

The pre-processing analytics in Veritas eDiscovery Platform provide a visual summary of the overall characteristics of a set of documents and present detailed analysis by custodian, timeline, and file type. Veritas eDiscovery Platform provides multi-language support and can automatically identify the language used in a document. And its Review & Production module offers transparent keyword searches of more than 500 different file types, including support for optical character recognition (OCR) of images containing text and analysis of spoken words in audio and video files.

“As we evaluated different eDiscovery solutions, we were very impressed with the processing, review, and classification capabilities within Veritas eDiscovery Platform,” Souza says. “We were also very impressed with the Veritas support team, and we are pleased that Veritas has an office in Sao Paulo.”

GRC Solutions deployed Veritas eDiscovery Platform with the Processing & Analysis, Review & Production, and Identification & Collection modules. Now, GRC Solutions is using Veritas eDiscovery Platform to accelerate evidence discovery in support of customers’ legal and

internal investigations. The solution’s data indexing makes searches run faster and streamlines data review. A simple search takes three to five seconds, and the solution can process 1 GB of data within about a minute and a half. The keyword search preview capability within eDiscovery Platform further accelerates the process by enabling users to select relevant keyword variations, and remove false-positive variations, prior to running a search.

“The processing capabilities are really important because we receive a lot of information from our clients,” Souza says. “Now we deliver results to customers 60 percent faster than we used to deliver them before we used Veritas eDiscovery Platform.”

At the same time, the quality of Veritas search gives GRC Solutions confidence that search results are complete. eDiscovery can simultaneously search for multiple fields using Boolean, stemming, wildcard, fuzzy, and proximity searches. “We put the keywords in Veritas eDiscovery,” Bordon says. “We can cross-reference the resulting information against reports. In addition to delivering results similar to those of other eDiscovery solutions, Veritas eDiscovery Platform delivers more qualitative results through artificial intelligence.”

And because eDiscovery Platform tracks user actions from logins and data exports to searches and tagging, GRC Solutions’ discovery services now have the highest level of defensibility.

GRC Solutions has also purchased Veritas Essential Support Services and Veritas Education Services. So far, Veritas has trained five GRC Solutions employees on use of the eDiscovery platform. “The Veritas training was amazing,” Souza says.

The solution and training have enabled GRC Solutions to improve its internal processes. “Veritas eDiscovery Platform helps us run even more efficiently,” Souza says. “We get a real operational gain on the investigation processes in the electronic discovery stage, saving us around USD150,000 a year by reducing the staff time needed to deliver the cases entrusted to us.”
