

Webhooks Capture and Archiving

By leveraging Webhooks, Veritas Merge1 customers can continue to support delivery of captured content into the archive target of their choice, while adding Webhooks as a new method of capture to their existing capabilities, without deploying any new software to their existing systems.



Events or activities generated by Microsoft Teams include all actions subject to compliance by every single monitored user on the platform. These “events” or “activities” include one-to-one chats between MS Team users who may not have yet migrated to online email accounts or are in a hybrid or mixed configuration(s).

One of the complicating factors in extending data retention policies to Teams is that Teams creates many different data objects from its various top-level capabilities. For example, simple chat content can be divided up into three different capabilities:

- 1 to 1 chat
- 1 to many chat
- Files introduced and viewed during chat

Other data types within Teams include group conversations, calendar invites, voice and video calls, meeting recordings, contacts, voicemail, transcripts, and wikis.

The underlying challenge with archiving Teams data is that Teams does not have its own single storage repository within Office 365 but instead stores Teams data in several other services within Office 365.


