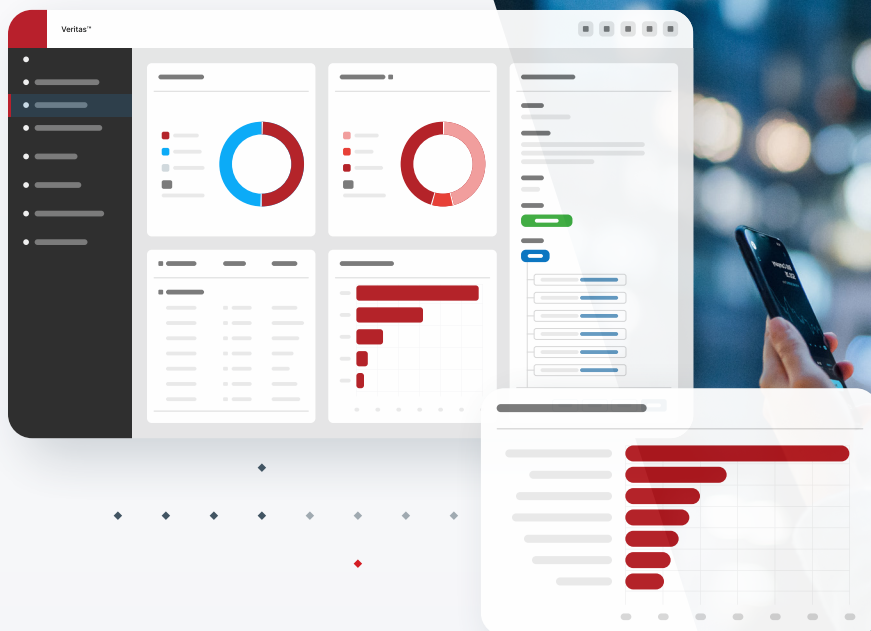

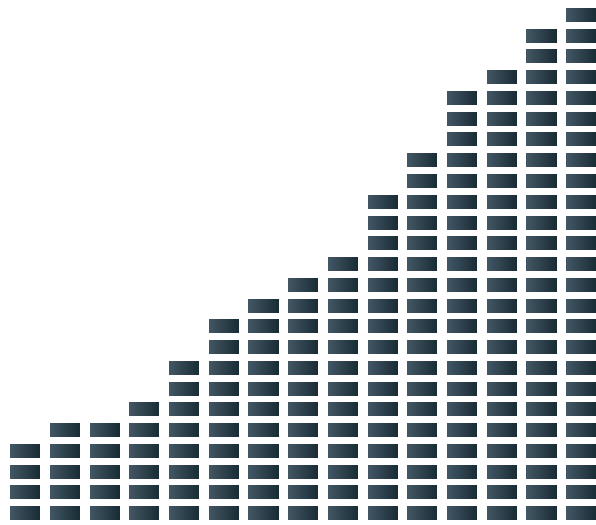

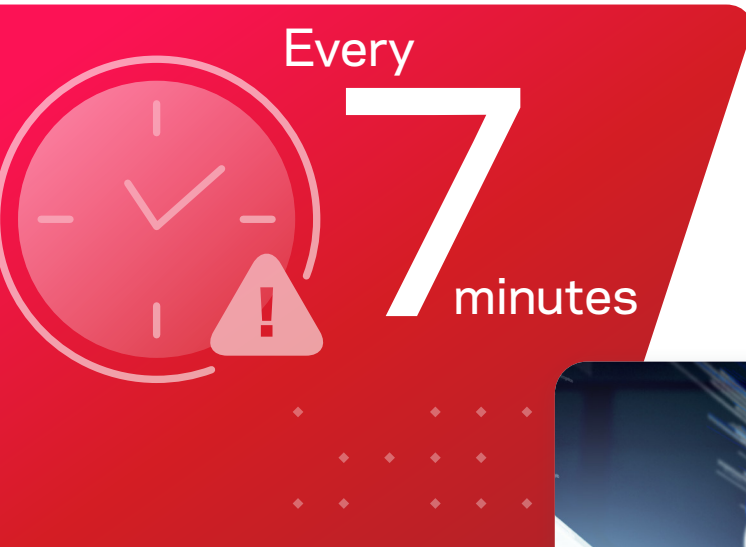

Poor data quality is costing organizations an average of \$11.8 million per year. As a result, it's imperative that organizations start cleaning up their information footprint immediately.⁵



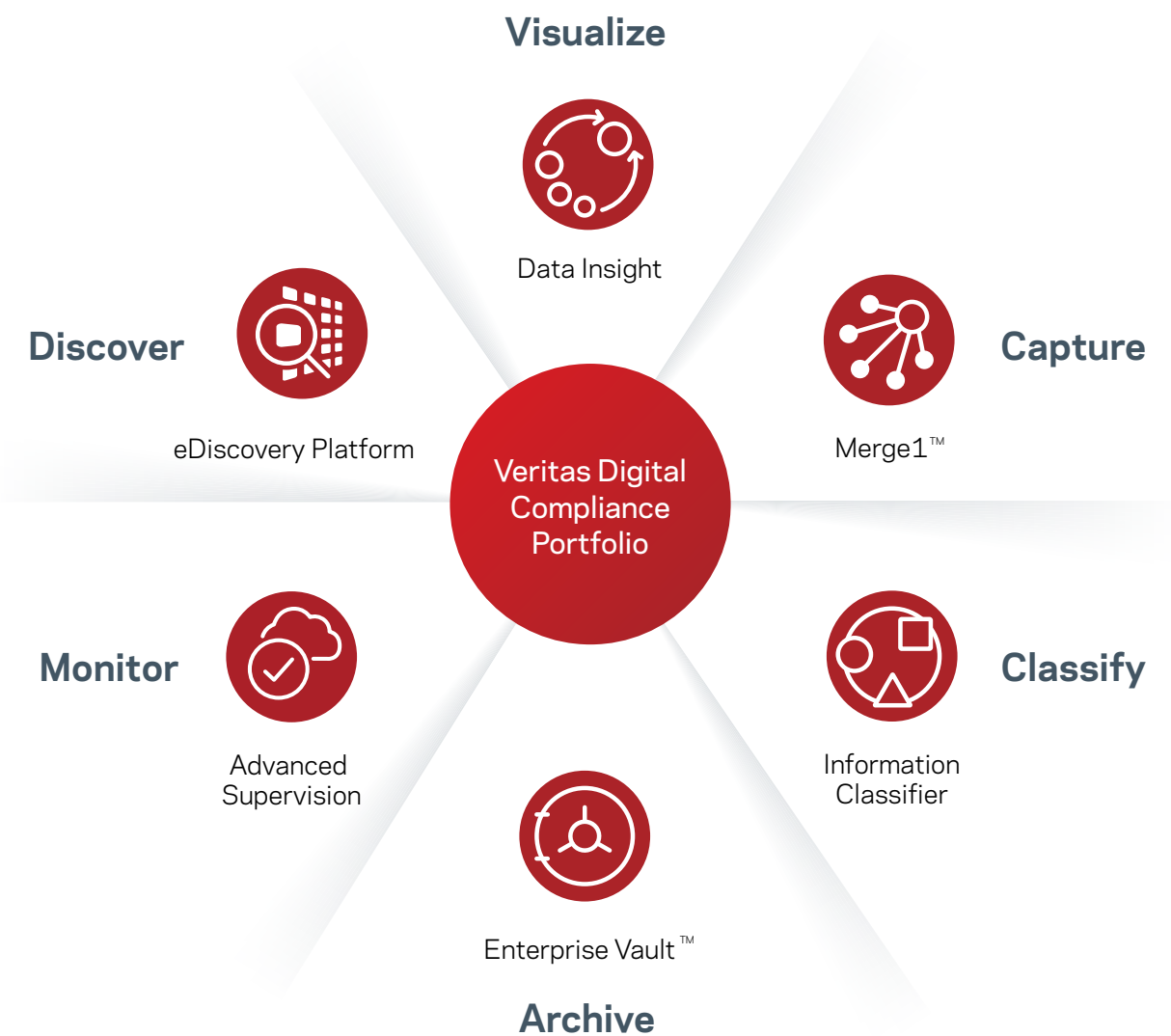

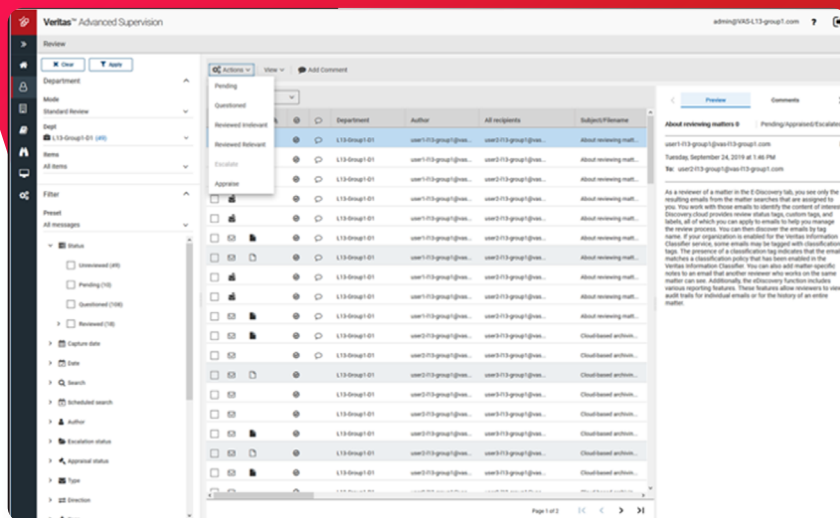
